2. collection and storage of personal data as well as type and purpose of their use

When you visit the website

When you visit our website www.stickmaschinen.de, the browser on your device automatically sends information to the server on my website. This information is temporarily stored in a so-called log file. The following information is recorded without your intervention and transmitted to the automated

Deletion saved:

- IP address of the requesting computer,
- Date and time of access,
- Name and URL of the retrieved file,
- Website from which access is made (referrer URL),
- the browser used and, if applicable, the operating system of your computer as well as the name of your access provider.

The mentioned data will be processed by me for the following purposes:

- Ensuring a smooth connection of the website,
- Guarantee a comfortable use of my website,
- evaluation of system security and stability as well as
- for other administrative purposes.

The legal basis for data processing is Art. 6 para. 1 sentence 1 f DSGVO. My legitimate interest follows from the purposes listed above for data collection. Under no circumstances do I use the data collected for the purpose of drawing conclusions about you personally.

Furthermore, I use cookies and analysis services when visiting my website. Further explanations can be found under point 4 of this data protection declaration.

3. passing on of data

Your personal data will not be transmitted to third parties for purposes other than those listed below.

I will only pass on your personal data to third parties if:

- you have given your express consent pursuant to Art. 6 para. 1 sentence 1 lit. a DSGVO,
- the disclosure pursuant to Art. 6 para. 1 sentence 1 f DSGVO is necessary to assert, exercise or defend legal claims and there is no reason to assume that you have an overriding interest worthy of protection in not disclosing your data,
- in the event that a legal obligation exists for the transfer pursuant to Art. 6 para. 1 sentence 1 lit. c DSGVO, and
- this is legally permissible and is necessary for the processing of contractual relationships with you in accordance with Art. 6 para. 1 sentence 1 lit. b DSGVO.

4. Cookies

I use cookies on my site. These are small files that your browser automatically creates and that are stored on your device (laptop, tablet, smartphone, etc.) when you visit my site. Cookies do no damage to your end device, do not contain viruses, Trojans or other malware.

Information is stored in the cookie that results in each case in connection with the specifically used terminal device. However, this does not mean that I immediately become aware of your identity.

The use of cookies serves on the one hand to make the use of my offer more pleasant for you. I use so-called session cookies to recognize that you have already visited individual pages of my website. These will be deleted automatically after leaving my site.

In addition, I also use temporary cookies that are stored on your end device for a specified period of time to optimize user-friendliness. If you visit my site again to use my services, it will automatically recognize that you have already been with me and what entries and settings you have made so that you do not have to enter them again.

On the other hand, I use cookies to statistically record the use of my website and to evaluate it for you for the purpose of optimising my offer (see point 5). These cookies enable me to automatically recognize when I visit my site again that you have already been with me. These cookies are automatically deleted after a defined period of time.

The data processed by cookies is required for the purposes mentioned to protect my legitimate interests and those of third parties pursuant to Art. 6 para. 1 sentence 1 letter f DSGVO.

Most browsers automatically accept cookies. However, you can configure your browser so that no cookies are stored on your computer or a message always appears before a new cookie is created. However, the complete deactivation of cookies can lead to the fact that you cannot use all functions of my website.

5. use of Vimeo plugins

For the integration of videos we use the provider Vimeo. Vimeo is operated by Vimeo, LLC, headquartered at 555 West 18th Street, New York, New York 10011.

On some of our websites we use plugins from the provider Vimeo. When you access the websites on our website that are provided with such a plugin - for example our media library - a connection to the Vimeo servers is established and the plugin is displayed. This will transmit to the Vimeo server which of our web pages you have visited. If you are logged in as a member of Vimeo, Vimeo will assign this information to your personal user account. When using the plugin, e.g. clicking the start button of a video, this information is also assigned to your user account. On some of our websites we use plugins from YouTube. When you access the websites on our website that are provided with such a plugin - for example our media library - a connection to the YouTube servers is established and the plugin is displayed. This transmits to the YouTube server which of our Internet pages you have visited. If you are logged in as a YouTube member, YouTube assigns this information to your personal user account. When using the plugin, e.g. clicking the start button of a video, this information is also assigned to your user account. 8. rights of the persons concerned

You have the right:

- to request information about your personal data processed by me in accordance with Art. 15 DSGVO. In particular, you may request information about the purposes of processing, the category of personal data, the categories of recipients to whom your data have been or will be disclosed, the planned storage period, the existence of a right to rectification, deletion, restriction of processing or opposition, the existence of a right of appeal, the origin of your data, if not collected by me, and the existence of automated decision-making including profiling and, if applicable, meaningful information about its details;

- to immediately request the correction of incorrect or complete personal data stored by us in accordance with Art. 16 DSGVO;
- to request the deletion of your personal data stored by me pursuant to Art. 17 DSGVO, unless the processing is necessary to exercise the right to freedom of expression and information, to fulfil a legal obligation, for reasons of public interest or to assert, exercise or defend legal claims;
- pursuant to Art. 18 DSGVO, to restrict the processing of your personal data if you dispute the accuracy of the data, if the processing is unlawful but you refuse to delete it and I no longer need the data, but you need it to assert, exercise or defend legal claims or you have filed an objection to the processing pursuant to Art. 21 DSGVO;
- pursuant to Art. 20 DSGVO, to receive your personal data that you have provided to me in a structured, current and machine-readable format or to request its transfer to another person responsible;
- in accordance with Art. 7 para. 3 DSGVO, to revoke your consent to us at any time. As a result, we will not use the data processing that is based on this consent not to be allowed to continue in the future and

9. right of objection

Whether a single page of our Internet presence is transmitted in encrypted form can be seen from the closed display of the key- or Lock icon in the lower status bar of your browser.

I also use suitable technical and organisational security measures to protect your data against accidental or intentional manipulation, partial or complete loss, destruction or against unauthorised access by third parties. My security measures will be implemented in accordance with technological developments. continuously improved.
